For your review, comments and approval is the proposed Asphalt Road Paving Project schedule for August 2015.

Week 1: **Sunday, August 2, 2015**: Boyson will transport the Better Roads equipment and lighter materials to LSJ. The rest of the week, **Monday, August 3 to Friday, August 7**, will be preparatory work on LSJ. There will be no daily transport via Boyson. LSJ will provide transportation via Little C for the Better Roads crew during this week.

Week 2: **Monday, August 10 to Friday, August 14 (30 loads total) via Boyson**

5:00 am - 3 truckloads asphalt - Red Hook (RH) to LSJ

10:00 am - 3 truckloads asphalt - RH to LSJ

2:00 pm - 6 trucks - LSJ to RH

Week 3: **Monday, August 17 to Friday, August 21 (30 loads total) via Boyson**

5:00 am - 3 truckloads asphalt - RH to LSJ

10:00 am - 3 truckloads asphalt - RH to LSJ

2:00 pm - 6 trucks - LSJ to RH

Week 4: **Monday, August 24 to Friday, August 28 (15-20 loads total) via Boyson**

5:00 am - 3 truckloads asphalt - RH to LSJ

10:00 am - 3 truckloads asphalt - RH to LSJ

2:00 pm - clean up, return equipment to STT

The Better Roads crew will also transported via Boyson during Weeks 2, 3 and 4.

Better Roads has planned a 5 day per week schedule. Better Roads will use Saturdays and Sundays for "rain days" makeup, if needed, and will be transported to and from LSJ within Boyson's schedule as needed.
