I spoke to Gary Anzalone, he asked if our GIV deal was moving fwd, his interest is our interior work if we purchase.

Gary works on a contract basis with Ben and Morris with Toy Store and personally knows Enrique. Gary brokers Planes and interior work, he is not involved with commission from Garret Burke or Pat Janas the listing brokers for Enrique. Gary informed me that Garret and Pat's sales contract agreement with the GIV expired, Garrett and Pat have no contractual obligation to present offers to Enrique.

Gary Anzalone speaks with Enrique directly regarding aircraft deals, along with J.C. (Juan Carlos) who is Enrique's CFO or similar title. Gary spoke to Enrique Last Thursday regarding the Global express he was looking at purchasing, This was same day I viewed the GIV in Opalocka, Gary told me Enrique is engaged in the Global Express deal, and has 10 days according to his LOI till his money goes hard from Last Thursday, (3 days remaining), Jack Pruitt is not the owner of the Global express, its another broker called Jet Effects who is listing agent on the Global,.. Gary also indicates Enrique changes his mind regarding deals, since the Toy store has tried 3 times to sell him an aircraft.
