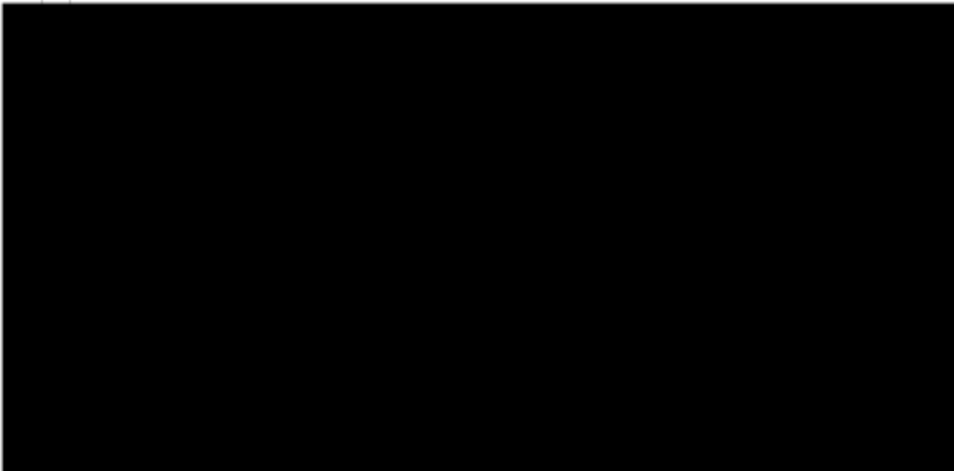
This may sound absolutely mad (to use a [REDACTED] colloquialism) but I do have some limited investigation experience.

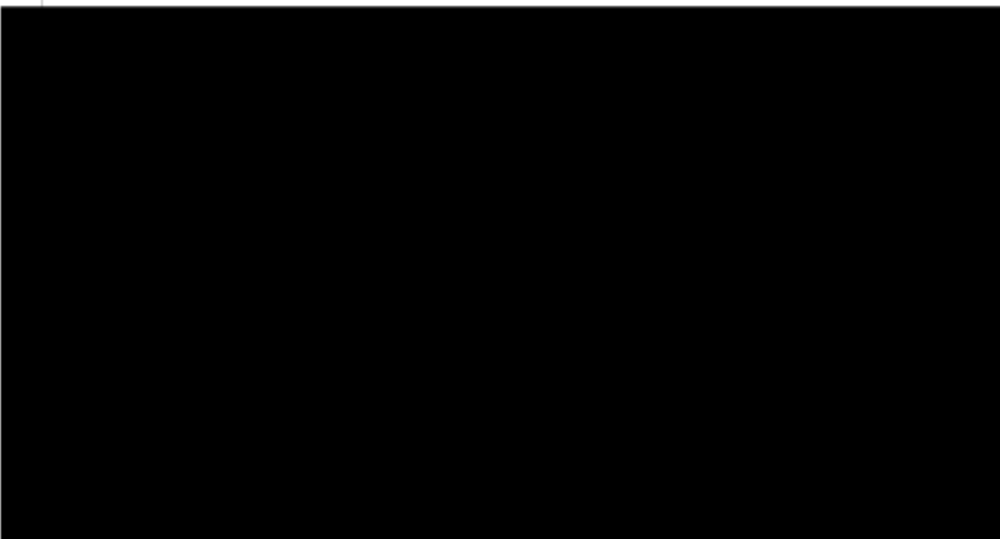

That is a figure I have been talking about recently as the recompense that i should get for having large chunks my 20's and 30's and 40's taken away from me/impacted by this r-a-p-i-s-t- and these people.. You know why I said that figure to a lawyer? Because my rapist..that is the figure he used all the time.. 20 million. He said he had too much money and 20 million was the right figure to have in life. He said 20 million the authorities never looked at..He said when you had 20 million no one ever investigated it or noticed it, but when you had 100 million they did.

I don't even know if my rapist would be on your list..as he was very clever.I know at least one middle man who handled things for him, and I may have found out another tonight.The timing of what happened to me fits..everything I know fits.
